# **ASF PERFORMANCE AWARDS 2015**



## INSTRUCTIONS

#### I Introduction

The ASF Performance Awards is the annual award for Asian Squash Federation (ASF) to honour top Asian players for their effort and achievement in squash during the year. The ASF has full power to manage the Award and to revise the rules governing the Awards.

#### II Awards Categories

- 1. <u>DATO ALEX LEE AWARD</u> The award is presented to an Outstanding Asian Player of the Year (Men & Women).
- 2. <u>HASSAN MUSA AWARD</u> The award is presented to an Outstanding Asian Junior Player of the Year (Boy & Girl).
- 3. <u>THE ASF AWARD</u> The award is presented to an Outstanding Team of the Year (Men's & Women's Team).
- 4. <u>THE ASF DEVELOPMENT AWARD</u> This award is presented to a Most Improved Team of the Year.

#### III Selection Criteria

#### 1. DATO ALEX LEE AWARD

- (a) Only players from ASF member nations shall be eligible for consideration for the award.
- (b) The performance and results of individual players at all levels of international competitions shall be considered.
- (c) Leadership qualities, team spirit, and good sportsmanship shall also be considered.

#### 2. HASSAN MUSA AWARD

(a) Only players from ASF member nations and who are under the age of 19 at any time of the year of the award shall be considered for the award.

- (b) The performance and results of individual players at all levels of international competitions shall be considered.
- (c) Leadership qualities, team spirit, and good sportsmanship shall also be considered.

#### 3. THE ASF AWARD

- (a) Only teams from ASF member nations shall be eligible for consideration for the award.
- (b) The performance and results of teams at all levels of international competitions shall be considered.

#### 4. THE ASF DEVELOPMENT AWARD

- (a) Only teams from ASF member nations shall be eligible for consideration for the award.
- (b) The performance and results of teams at all levels of international competitions shall be considered.
- (c) Huge jumps of the team in terms of results will be an important criterion.

#### IV Nomination Procedure

- 1. Awards Period: 1<sup>st</sup> January 2015 31<sup>st</sup> December 2015
- 2. All ASF member nations will be invited to put up nomination in January 2016.
- 3. Please complete and submit the Nomination Form/s provided by ASF in duplicate, duly declared and signed with Association's seal, to the Secretariat on or before the closing date for nominations. Nomination forms are also downloadable from the ASF's website at *www.asiansquash.org*
- 4. Closing date for nominations: **<u>15 February 2016</u>**.
- 5. Late nomination or nominations with insufficient information will not be considered.

#### V Selection Procedure

- Chaired by ASF Coaching Director Mr. Tony Choi (HKG) and comprised of three additional panel members including Maj (R) S. Maniam (MAS), Mr. Koo Ryun-Hoe (KOR) and Mr. Allaaeldeen Allouba (QAT), a Selection Panel will be formed for selecting all awards' recipients for the final endorsement of the ASF Management Committee.
- 2. The above selection criteria will serve as a reference for the Selection Panel to select the awards' recipients, and the Selection Panel has the discretion to adjust the criteria, if necessary.
- 3. All awards' recipients shall be announced by the ASF Office in April 2016 and the Awards will be presented during the 2016 Asian Team Championships.

#### VI Secretariat

1. The ASF Office in Hong Kong will be the Secretariat.

- 2. Duties of the Secretariat
  - (a) Despatch forms to all member nations.
  - (b) Process nominations and submit to Selection Panel.
  - (c) Prepare and conduct the ASF Performance Awards ceremony.

#### VII Prizes

A Perpetual Trophy shall be presented to each awards' recipient. The Perpetual Trophy shall be retained by the ASF at all times.
